What is this Product?

Product Type:

Undertaking for Collective Investment in Transferable Securities (UCITS) Fund.

Investment Objective:

US equity market.

Maturity:

The Duration of the Sub-Fund is indefinite.

Income:

This Class is an accumulator class so the income from investments held for the Class will not be paid out as dividends. Instead, income will be re-invested and reflected in the value of the payment of a Dividend is appropriate.

Buying and Selling of Shares:

You may buy and sell Class GBP DDD Shares (this "Class") on each business day (Monday to Friday other than public and bank holidays in Malta) subject to certain cut off times.

Currency:

The Class in the Sub-Fund is denominated in GBP.

The Sub-Fund is generally suitable for investors willing to hold their investment for a minimum period of five years.

Investment Policy:

The Investment Manager ("We") are expected to invest mainly in listed equities and/or eligible ETFs (the underlying of which will be exchange traded equities). Exposure to these asset classes may be achieved both directly or indirectly through eligible UCITS funds having The Castlestone Low Volatility Income UCITS Fund (the "Sub-Fund") aims at generating similar investment policies and objectives as those of the Sub-Fund. In aggregate, no more capital growth by targeting equities that may exhibit lower volatility relative to the broader than 10% of the Sub-Fund's assets will be invested in units or shares of UCITS, including those which are established as exchange traded funds. The Sub-Fund may also invest in writing (selling) covered call options in order to ensure efficient portfolio management. The Sub-Fund may limitedly invest up to 10% of its assets in closed-ended CISs satisfying the requirements of the Eligible Assets Directive.

The Sub-Fund is expected to invest mainly in the US equity market with focus on equities Shares. Up to 100% of the assets of the Sub-Fund may be invested in equities. The Sub-Fund is however not expected to have any specific industry, market capitalisation or market sector bias.

What happens if AQA Capital Limited is unable to pay out?
