What is this Product?

Investment Policy:

The Investment Manager ("We") are expected to invest mainly in listed equities and/or eligible ETFs (the underlying of which will be exchange traded equities). Exposure to these asset classes may be achieved both directly or indirectly through eligible UCITS funds having The Castlestone FAANG+ UCITS Fund (the "Sub-Fund") aims to generate capital growth similar investment policies and objectives as those of the Sub-Fund. In aggregate, no more than 10% of the Sub-Fund's assets will be invested in units or shares of UCITS, including those which are established as exchange traded funds. What happens if AQA Capital Limited is unable to pay out?
