What is this Product?

Product Type:

Investment Objective:

In addition, the Sub-Fund may, whether for temporary, defensive or other purposes deemed to be in the best interest of investors, invest in other eligible assets under the UCITS Directive and the Eligible Assets Directive (as applicable), including Money Market This Class is an accumulator class so the income from investments held for the Class will not Instruments, and cash and cash equivalents. We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

What happens if AQA Capital Limited is unable to pay out?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.
