What is this Product ?

Product Type:

Undertaking for Collective Investment in Transferable Securities (UCITS) Fund.

Investment Objective :

The investment objective of the Sub-Fund is to maximize capital growth and generate an attractive total return consisting of current income and capital appreciation, with a lower risk/reward profile associated with investing in credit markets.

Maturity:

The Duration of the Sub-Fund is indefinite.

Income:

This Class is an accumulator class so the income from investments held for the Class will not be paid out as dividends. Instead, income will be re-invested and reflected in the value of the Shares. The Directors reserve the right to pay Dividends at any time if they consider that a payment of a Dividend is appropriate.

Buying and Selling of Shares:

You may buy and sell Class EUR L Retail Shares (this "Class") on each business day (Monday to Friday other than public and bank holidays in Malta) subject to certain cut off times.

Currency:

The Class in the Sub-Fund is denominated in EUR.

Target Investors:

The Sub-Fund is generally suitable for investors willing to hold their investment for a minimum period of five years.

Investment Policy:

To capitalise on attractive opportunities, while minimising risk, the Investment Manager shall primarily allocate investments across a universe of fixed and/or floating listed corporate and/or sovereign bonds (whether listed or unlisted). The Sub-Fund may invest in money market instruments and perpetual bonds. Exposure to these assets may be achieved either directly or indirectly using UCITS eligible Collective Investment Schemes including ETFs. The Sub-Fund may invest in other collective investment schemes which are also managed by the Investment Manager. The Sub-Fund will not be biased towards any particular duration. The Sub-Fund may also invest in exchange traded and over the counter derivatives including but not limited to currency forwards and Credit Default Swaps (CDS). OTC derivatives will be entered into with Approved Counterparties. The Sub-Fund is being actively managed.

The Sub-Fund may also invest in structured products. The Investment Manager will only invest in Structured Products which limit the maximum loss that the fund may sustain to 100% of the amount invested. The underlying instruments of the said structured products may be all types of eligible instruments in terms of the UCITS Directive and which fall within the parameters of the Sub-Fund's investment policy as set out in further detail above. The Sub-Fund may also limitedly invest up to 10% of its assets in unlisted securities satisfying the requirements of the Eligible Assets Directive.

The Investment Manager ("We") will seek to maintain an average credit quality of Ba by Moody's or BB by S&P or a Bloomberg composite of BB, although the portfolio may contain securities rated lower or higher. We will invest in a diversified portfolio of investments over a broad base of issuers and industries. We are not restricted to any particular duration, market sector or industry. However, the Sub-Fund is expected to be biased towards the US. The Investment Manager shall aim to manage credit risk and interest rate risk through credit analysis and credit diversity.

The Sub-Fund may invest up to 20% of its NAV in SPACs which will be monitored and invested in mainly during the period prior to a target announcement and/or listed equities.

To capitalise on attractive opportunities, while minimising risk, the Investment Manager shall primarily allocate investments across a universe of fixed and/or floating listed corporate and/or sovereign bonds (whether listed or unlisted). The Sub-Fund may invest in money market instruments and perpetual bonds. Exposure to these assets may be achieved either directly or indirectly using UCITS eligible Collective Investment Schemes including ETFs. The Sub-Fund may invest in other collective investment schemes which are also managed by the Investment Manager. The Sub-Fund will not be biased towards any particular duration.

For temporary or defensive purposes, we may hold short-term fixed income instruments, money market funds, cash and cash equivalents. The Sub-Fund may also hold such securities for cash management purposes.

What are the risks and what could I get in return?

 The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early or you may have to pay significant extra costs to cash in early. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

Credit Risk – Bonds or other debt securities held for the Sub-Fund involve credit risk represented by the possibility of default by the issuer.

Exchange Rate Risk – the Sub-Fund may invest in assets denominated in currencies other than USD, thereby exposing the Sub-Fund to fluctuations in exchange rates.

Charges and Expenses – Charges and expenses will be charged against capital, which may have the effect of constraining capital growth.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium to low risk class. This rates the potential losses from future performance at a medium to low level, and poor market conditions are unlikely to impact our capacity to pay you.

There is no minimum guaranteed return. You could lose some or all of your investment. (see the section ‘what happens if we are unable to pay you’)

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The Sub-Fund may also be exposed to additional risks which are not adequately captured by the risk indicator and may cause additional loss.

Performance Scenarios

The table below shows the money you could get back over the next 5 years, under different scenarios, assuming an investment of EUR 10,000. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products.

The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the investment. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you. What happens if AQA Capital Limited is unable to pay out?

The Sub-Fund is a segregated portfolio whose assets and liabilities are to be treated as a patrimony separate from the assets and liabilities of each other sub-fund and of the Company. The Classes of the Sub-Fund do not constitute segregated portfolios. Please refer to the Prospectus for further details.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future.

Costs Over Time

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs and show you the impact that all costs will have on your investment over time.
