Income:

This Class is an accumulator class so the income from investments held for the Class will not be paid out as dividends. Instead, income will be re-invested and reflected in the value of the Shares. The Directors reserve the right to pay Dividends at any time if they consider that a payment of a Dividend is appropriate. The Sub-Fund is expected to invest mainly in the US equity market with focus on equities in aggregate are expected to have lower volatility characteristics relative to the broader U.S.

Buying and Selling of Shares:

You may buy and sell Class EUR BB Shares (this "Class") on each business day (Monday to Friday other than public and bank holidays in Malta) subject to certain cut off times.

Currency:

The Class in the Sub-Fund is denominated in EUR.

Target Investors:

The Sub-Fund is generally suitable for investors willing to hold their investment for a minimum period of five years.

he Investment Manager ("We") are expected to invest mainly in listed equities and/or ligible ETFs (the underlying of which will be exchange traded equities). Exposure to these sset classes may be achieved both directly or indirectly through eligible UCITS funds having imilar investment policies and objectives as those of the Sub-Fund. In aggregate, no more han 10% of the Sub-Fund's assets will be invested in units or shares of UCITS, including hose which are established as exchange traded funds. The Sub-Fund may also invest in writing (selling) covered call options in order to ensure efficient portfolio management. The ub-Fund may limitedly invest up to 10% of its assets in closed-ended CISs satisfying the equirements of the Eligible Assets Directive.

Where deemed to be in the best interests of investors, the Sub-Fund may also limitedly invest a portion of its assets in convertible debt instruments.

The Sub-Fund is expected to invest mainly in the US equity market with focus on equities listed by issuers domiciled or with country of risk being the United States of America, which in aggregate are expected to have lower volatility characteristics relative to the broader U.S. equity market. Up to 100% of the assets of the Sub-Fund may be invested in equities. The Sub-Fund is however not expected to have any specific industry, market capitalisation or market sector bias.

The Sub-Fund may also make use of OTC currency forwards for risk reduction purposes. Any costs related to these will be borne by the Sub-Fund itself. The underlying of OTC derivatives will be limited to currencies. OTC derivatives will be entered into with Approved Counterparties.

The Sub-Fund may hold cash and cash equivalents for cash management purposes pending investment in accordance with its investment policy and to meet operating expenses and redemption requests. The Sub-Fund is being actively managed.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The figures are estimates and may change in the future.
