### What is this Product?

### Product Type:

Undertaking for Collective Investment in Transferable Securities (UCITS) Fund.

#### Investment Objective:

The Castlestone Low Volatility Income UCITS Fund (the "Sub-Fund") aims at generating capital growth by targeting equities that may exhibit lower volatility relative to the broader US equity market.

#### Maturity:

The Duration of the Sub-Fund is indefinite.

#### Income:

This Class is an accumulator class so the income from investments held for the Class will not be paid out as dividends. Instead, income will be re-invested and reflected in the value of the Shares. The Directors reserve the right to pay Dividends at any time if they consider that a payment of a Dividend is appropriate.

# Buying and Selling of Shares:

You may buy and sell Class GBP FFF Shares (this "Class") on each business day (Monday to Friday other than public and bank holidays in Malta) subject to certain cut off times.

# Currency:

The Class in the Sub-Fund is denominated in GBP.

# Target Investors:

The Sub-Fund is generally suitable for investors willing to hold their investment for a minimum period of five years.

#### nvestment Policy:

The Investment Manager ("We") are expected to invest mainly in listed equities and/or eligible ETFs (the underlying of which will be exchange traded equities). Exposure to these asset classes may be achieved both directly or indirectly through eligible UCITS funds having similar investment policies and objectives as those of the Sub-Fund. In aggregate, no more than 10% of the Sub-Fund's assets will be invested in units or shares of UCITS, including those which are established as exchange traded funds. The Sub-Fund may also invest in writing (selling) covered call options in order to ensure efficient portfolio management. The Sub-Fund may limitedly invest up to 10% of its assets in closed-ended CISs satisfying the requirements of the Eligible Assets Directive.

Where deemed to be in the best interests of investors, the Sub-Fund may also limitedly invest a portion of its assets in convertible debt instruments.

The Sub-Fund is expected to invest mainly in the US equity market with focus on equities listed by issuers domiciled or with country of risk being the United States of America, which in aggregate are expected to have lower volatility characteristics relative to the broader U.S. equity market. Up to 100% of the assets of the Sub-Fund may be invested in equities. The Sub-Fund is however not expected to have any specific industry, market capitalisation or market sector bias.

The Sub-Fund may also make use of OTC currency forwards for risk reduction purposes. Any costs related to these will be borne by the Sub-Fund itself. The underlying of OTC derivatives will be limited to currencies. OTC derivatives will be entered into with Approved Counterparties.

The Sub-Fund may hold cash and cash equivalents for cash management purposes pending investment in accordance with its investment policy and to meet operating expenses and redemption requests. The Sub-Fund is being actively managed.

# What happens if AQA Capital Limited is unable to pay out?

The Sub-Fund is a segregated portfolio whose assets and liabilities are to be treated as a patrimony separate from the assets and liabilities of each other sub-fund and of the Company. The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The figures are estimates and may change in the future.
