Target Investors:

The Sub-Fund is generally suitable for investors willing to hold their investment for a minimum period of five years.

Investment Policy: The Investment Manager ("We") are expected to invest mainly in listed equities and/or eligible ETFs (the underlying of which will be exchange traded equities). Exposure to these asset classes may be achieved both directly or indirectly through eligible UCITS funds having The Castlestone Low Volatility Income UCITS Fund (the "Sub-Fund") aims at generating similar investment policies and objectives as those of the Sub-Fund. In aggregate, no more those which are established as exchange traded funds. The Sub-Fund may also invest in writing (selling) covered call options in order to ensure efficient portfolio management. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.
