## What is this Product ?

### Product Type:

Undertaking for Collective Investment in Transferable Securities (UCITS) Fund.

### Investment Objective :

The investment objective of the Sub-Fund is to achieve medium to long-term capital growth. There is no guarantee that the investment objective of the Sub-Fund will be achieved, and investment results may vary substantially over time.

### Maturity:

The Duration of the Sub-Fund is indefinite.

### Income:

This Class is an accumulator class so the income from investments held for the Class will not be paid out as dividends. Instead, income will be re-invested and reflected in the value of the Shares. The Directors reserve the right to pay Dividends at any time if they consider that a payment of a Dividend is appropriate.

### Buying and Selling of Shares:

You may buy and sell Class EUR C Retail Shares (this "Class") on each business day (Monday to Friday other than public and bank holidays in Malta) subject to certain cut off times.

### Currency:

The Class in the Sub-Fund is denominated in EUR.

### Target Investors:

The Sub-Fund is generally suitable for investors willing to hold their investment for a minimum period of five years.

### Investment Policy:

The Sub-Fund may invest in a range of securities (whether listed or unlisted) including corporate and/or government bonds and/ or equities and/ or units of other eligible UCITS and/or other non UCITS collective investment schemes (including ETFs). The Sub-Fund is not expected to have any bias towards any specific industrial, rating, market capitalisation, geographic or other market sector. At any point in time the Sub-Fund may be 100% exposed to equities or bonds.

The Sub-Fund may invest in equities and/or bonds of companies whether rated or unrated. The Sub-Fund will not be biased towards bonds of any particular duration.

When investing in units in collective investment schemes, the Sub-Fund may only invest in eligible UCITS and/or other non UCITS collective investment schemes that invest predominantly in transferable securities and/or other eligible assets such as money market instruments, deposits and financial derivatives instruments. As a result of exposure to collective investment schemes, investors may be subject to the risk of duplication of fees and commissions. The maximum management fees of eligible UCITS and/or other non UCITS collective investment schemes in which the Sub-Fund may invest shall not exceed 3% per annum of the target fund's assets. The Sub-Fund is not expected to invest in collective investment schemes which are managed by the Investment Manager.

The Sub-Fund may also invest in exchange traded and over the counter derivatives including but not limited to currency forwards, CFDs and swaps. The underlying of the said derivative instruments may be all types of eligible underlying in terms of the UCITS Directive, including but not limited to currencies, financial indices and interest rates. The Sub-Fund shall enter into OTC derivatives with Approved Counterparties. The Sub-Fund will bear the associated costs and fees in connection with the use of such instruments. These fees will generally be payable to counterparties in OTC FDIs. Such counterparties are not expected to be related to the Company and/ or the Investment Manager. The counterparties will not have any discretion in relation to the composition or management of the Sub- Fund's investment portfolio or over the underlying of the financial counterparty in relation to any investment portfolio transaction.

Exchange traded derivative exposures may include but shall not be limited to futures, put and call options on equity securities, on equity indices, on currencies, on credit indices and on interest rates. Indices shall satisfy the criteria of 'Financial Indices' as per the MFSA Rules. The Investment Manager shall aim to manage the portfolio's credit risk and shall aim to minimise volatility through credit analysis and diversification over a broad base of issuers, industries and geographies.

For investment, temporary or defensive purposes, the Sub-Fund may invest in short-term fixed income instruments, money market instruments, money market funds and cash and cash equivalents. The Sub-Fund may also at any time hold such securities for cash management purposes, pending investment in accordance with its Investment Policy and to meet operating expenses and redemption requests. Upon the discretion of the Investment Manager, and depending on market cycles and investment opportunities, the Sub-Fund may be fully invested in corporate and/or government bonds.

## What are the risks and what could I get in return?

 The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early or you may have to pay significant extra costs to cash in early. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

There is no minimum guaranteed return. You could lose some or all of your investment. (see the section 'what happens if we are unable to pay you')

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Duplication of Fees – Given that the Sub-Fund may invest in other collective investment schemes, there may be a risk of duplication of fees and commissions charged against the capital of the Sub-Fund.

Credit Risk – Bonds or other debt securities held for the Sub-Fund involve credit risk represented by the possibility of default by the issuer.

Exchange Rate Risk – the Sub-Fund may invest in assets denominated in currencies other than Euro, thereby exposing the Sub-Fund to fluctuations in exchange rates.

### Performance Scenarios

### What happens if AQA Capital Limited is unable to pay out?

### What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future.

### Costs Over Time
