Objectives and Investment Policy

Investment Objective: The AQA Flexible Allocation Fund (the “Sub-Fund”) aims to generate current income and achieve an increase in long-term capital, while having simultaneous risk diversification.

Investment Policy: The Investment Manager (“We”) are expected to invest in a diversified portfolio of stocks (substantially dividend paying), convertible securities and debt securities. The Sub-Fund shall primarily invest in corporate and government bonds and also in equity securities of large-to-mid cap companies which are domiciled or listed in North America or Europe. Securities held may be of investment grade, sub-investment grade and unrated. We may also invest in convertible bonds, in warrant-linked bonds whose underlying warrants relate to securities and in participation and dividend right certificates. To pursue its investment goals, the Sub-Fund may invest in equity related and fixed-income related transactions involving derivative instruments including futures, put and call options on equity securities, equity indices, credit indices and interest rates and also in equity-related and fixed-income-related ETF and other UCITS-complaint collective investment schemes.

For temporary or defensive purposes we may hold short-term fixed income instruments, money market funds and cash and cash equivalents.

The Sub-Fund is also expected to invest in FDIs, including currency forwards, and ETFs for hedging and risk management purposes. The investment policy shall have no sector or industry bias.

Management Discretion: The Investment Manager has the discretion to buy and sell investments on behalf of the Sub-Fund within the limits of the Objective and Investment Policy.

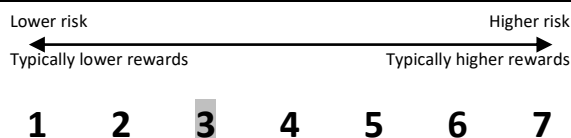
Income: This Class is an accumulator class so the income from investments held for the Class will not be paid out as dividends. Instead, income will be re-invested and reflected in the value of the Shares. The Directors reserve the right to pay Dividends at any time if they consider that a payment of a Dividend is appropriate.

Buying and Selling Shares: You may buy and sell Class A EUR Retail Shares (this “Class”) by close of business day on the first business day of every calendar fortnight and/or such other day or days as the Directors may determine from time to time. Subscriptions are only at the discretion of the Investment Manager.

Currency: The Class in the Sub-Fund is denominated in Euro.

Recommendation: This Sub-Fund may not be appropriate for investors who plan to withdraw money within less than 3 years.

Risk and Reward Profile



The above risk and reward indicator rates this Sub-Fund as category 3 meaning that the Sub-Fund offers a moderate risk of making a loss but also a moderate chance of making gains. It should be noted that even the lowest category on the indicator does not mean risk free. The rating shown is not guaranteed and may change over time.

The Sub-Fund’s rating reflects the nature of its investments and the corresponding risks to which the Fund is exposed. These risk factors, which include the risks listed below, may affect the value of the Sub-Fund’s investments or expose the Sub-Fund to losses:

Duplication of Fees – Given that the Sub-Fund may invest in other collective investment schemes, there may be a risk of duplication of fees and commissions charged against the capital of the Sub-Fund.

Exchange Rate Risk – The Sub-Fund may invest in assets denominated in currencies other than Euro, thereby exposing the Sub-Fund to fluctuations in exchange rates.

Charges and Expenses - Charges and expenses will be charged against capital, which may have the effect of constraining capital growth.

Charges

The **entry** and **exit** charges shown are maximum figures. In some cases you might pay less – you can find this out from your financial adviser.

The **ongoing charges** figure is an estimate of the Sub-Fund charges based on last year's expenses for the year ending December 2017. This figure may vary from year to year. It excludes performance fees, portfolio transaction costs, except in the case of an entry/exit charge paid by the Sub-Fund when buying or selling units in another collective investment undertaking.

Past Performance



The chart on the left shows the Class A Shares' annual performance in EUR for the full calendar year of 2017. It is expressed as a percentage change of the net asset value at each year-end on the basis that any distributable income of the Fund has been reinvested. The performance data includes tax, ongoing charges and portfolio transaction costs but excludes any entry and exit charges.

The Class A Shares was launched in 2016. 2017 is the only full calendar year of performance to date.
